FOREWORD TO THE FIFTH GENERATION IDP 2022-2027

It is with hope and optimism that we table the Fifth Generation IDP 2022-2027 for adoption. The adoption of the integrated development plan comes amid various challenges confronting the municipality.

It is worth noting that the adoption comes whilst the municipality is having to manage the ongoing protest by organised labour in the municipality. This protest has been somewhat unfriendly at times, but of significance is that it has put the municipality on a back footing insofar as resources and essential services must be delivered. It must be borne in mind that we will suffer the aftermath of this protest long into the future. However, together we can overcome the resultant burdens from the protest.

The Fifth Generation IDP 2022-2027 represents an instrument by which our term of office will shape and be judged by the future generations. We must therefore ensure that our incumbency prevails against all the challenges that we will face, lest we fail and leave a tainted legacy.

The whole country is still battling to manage the COVID-19 pandemic as well as the effects of what some, refer to as climate change induced conditions. This pandemic continues to cause untold hardships to our communities at large, whilst the inclement weather conditions remain a risk that we will live with for the unforeseeable future. The fifth Generation IDP 2022-2027 must seek to enhance mechanisms which must mitigate against the ensuing challenges from COVID-19 and the prevalent inclement weather conditions.

The adoption of the Fifth Generation IDP 2022-2027 acknowledges the pivotal role that cooperative governance must play. The municipalities across the country are facing very difficult socio-economic conditions which require both Local, Provincial & National government to immediately consider mechanisms to cushion our communities.

The national government has in response to the principle of intergovernmental relations, introduced the District Development Model. The purpose of this model is to coordinate developmental planning and to harness all the resources from local to national level. The Fifth Generation IDP has incorporated the aspects of the DDM and the plans in compliance with the good intentions of national policy directive in this regard. It must be appreciated that the DDM is still at its infancy, and we hope to learn and improve as time evolve.

The Fifth Generation is adopted with an acknowledgement that we have a lot to work on regarding our internal systems. It is regrettable that we do have a huge amount of money that is owned to municipality, this is from individual residences, from private and from government departments. The new administration will seek to ensure that appropriate actions are taken to collect from those that continue to be in arrears, whilst it appears as if they can afford to pay. The administration will be expected to ensure that these matters are attended to as it will form the basis for the performance assessments for various personnel annually

The IDP highlights areas with great potential to enhance the Local Economic Development. We must seek to draw from these opportunities robustly to ensure that our communities benefit from this potential without delay. The Spatial Development Rationale characterises great features of potential economic development. We are hoping to source technical know-how to ignite industrialization of our municipality. We do appreciate the challenges that come with our old and sometimes obsolete infrastructure. The municipal resources limited as they are, do provide an opportunity for us to ensure a reasonable maintenance of our municipal infrastructure.

In conclusion we must acknowledge the status of Children & Women, who continue to bear the burden of our social ills. Gender based violence has reached unimaginable proportions throughout the country. The people living with disability continue to be marginalised, even in our local municipality. Maquassi Hills must contribute towards reducing these limitations on people living with disability.

Our communities are overburdened by substance abuse across societies. Our schools have become targets for distributing these deadly substances. There is a need to deal with prevalence of substances as an emergency, because if we do not deal with this monster now, our future will continue to be bleak.

Tuberculosis and HIV related illnesses continue to ravage our families and friends, this happens even when these are believed to be reasonably manageable conditions. We must therefore seek to contribute towards primary health care of our communities through cooperative governance.

Local government is at the coal face of all these social ills, it will therefore be remiss of us not talk about all of them and deliberately seek to contribute towards eradicating them. The IDP of the municipality remains a vehicle by which we can systematically contribute. We must all recognize that the challenges seem to be very difficult and insurmountable, however together, in common purpose we can find a way through all of it.

Maquassi Hills has recorded great strides since the advent of democracy in improving the lives of our communities. This we must never forget as we agonize about all these prevailing difficulties.

Our communities continue to receive all the basic services notwithstanding our limitations. We must draw from these baselines as we forge into the future. We were among the first municipalities in the country to eradicate bucket systems, we have been recognized as a municipality with better structures of RDP houses, we are currently among the municipalities who reasonably spent our allocations on properly and on time. All these we raise to say, we must never look down on ourselves irrespective of our size and form.

Where there is a will, there is a way. Let us all commit in common purpose irrespective of our diversity so that we can improve the lives of our communities

INTRODUCTION

The Municipal Systems Act, no 32 of 2000 requires the municipal council, reasonably after its election into office, to craft and adopt at least a five-year developmental plan for its term of office. The plan must be integrated and developmental and should seek to address the current service delivery needs and to look forward into the future for developments.

The national government has adopted the district development model in 2019.

"The District Development Model builds on the White Paper on Local Government (1998), which seeks to ensure that "local government is capacitated and transformed to play a developmental role". The White Paper says developmental local government "is local government committed to working with citizens and groups within the community to find sustainable ways to meet their social, economic and material needs and improve the quality of their lives".

To which end, developmental local government is seen as having four interrelated characteristics of "maximising social development and economic growth; integrating and coordinating; democratising development; and leading and learning". For local government to advance this, the Constitution calls on "national and provincial governments [to] support and strengthen the capacity of municipalities to manage their own affairs".

Therefore, the model is a practical Intergovernmental Relations (IGR) mechanism to enable all three spheres of government to work together, with communities and stakeholders, to plan, budget and implement in unison."

The Dr Kenneth Kaunda District Municipality has adopted a district development model profile which seeks to highlight the characteristics of all the municipalities in the district. This profile will serve as a guiding tool for the developmental plans of municipalities in the district.

The objectives of the District Development Model are to:

Coordinate a government response to challenges of poverty, unemployment, and inequality particularly amongst women, youth and people living with disabilities.

Ensure inclusivity by gender budgeting based on the needs and aspirations of our people and communities at a local level. Narrow the distance between people and government by strengthening the coordination role and capacities at the District and City levels.

Foster a practical intergovernmental relations mechanism to plan, budget and implement jointly to provide a coherent government for the people in the Republic; (solve silo's, duplication, and fragmentation) maximise impact and align plans and resources at our disposal through the development of "One District, One Plan and One Budget".

Build government capacity to support municipalities. Strengthen monitoring and evaluation at district and local levels. Implement a balanced approach towards development between urban and rural areas. Maquassi Hills Local Municipality should follow a process in which it prepares a tool for the advancement of its strategic objectives. This intentional and intensive exercise is because of Municipal Systems Act, of which, inter-alia, its intentions are to provide mechanisms by which local government will function efficiently and as an organic whole.

The Fifth Generation IDP 2022-2027 was done in keeping with the following objects of local government, viz,

The Constitution of the Republic of South Africa, Act No. 108 of 1996, and sec 152(1) states the objects of local government, viz

- (a) To provide democratic and accountable government for local community
- (b) To ensure the provision of sustainable services to the communities
- (c) To promote social and economic development
- (d) To promote a safe and healthy environment and
- (e) To encourage the involvement of community organizations in the matters of local government.

STATUS OF INTEGRATED DEVELOPMENT PLAN [IDP]

The Municipal Systems Act, no 32 of 2000 defines the status of the municipal IDP as follows,


- IDP is the principal strategic planning instrument, which guides and informs all planning and development, and all decisions about planning, management, and development in the municipality
- It binds the municipality in the exercise of its executive authority, except to the extent of any inconsistency between a municipality's integrated development plan and national or provincial legislation, in which case such legislation prevails
- It binds all the other persons to the extent that those parts of the integrated development plan that impose duties or affect the rights of those persons have been passed as by-laws, and
- It should be a product of intergovernmental and inter-spherical planning

Phase 5: Approval

Period: April-May

Draft review must be ready for approval and put to the public for comments and inputs for at least a period of **21 days**

SECTION B: SITUATIONAL ANALYSIS

Maquassi Hills Local Municipality is a category B local municipality, which came into being after the diestablishment of the former Leeudoringsstad, Witpoort, Makwassie and Wolmaransstad municipalities, it is in the Western portion of Dr Kenneth Kaunda District Municipality (DC 40)

There are rural settlements and villages [*Community Property Associations*] that are incorporated in the Municipality, these areas need services either from Maquassi Hills Municipality (NW 404) and/or Dr Kenneth Kaunda District Municipality.

The municipality has a variety of challenges that must be always pursued, these challenges range from poor and obsolete infrastructure, poverty, and service delivery backlog et cetera.

The municipality consults community regularly to get the priorities that must be planned for and integrated with both Provincial & National governments plans. It is from these data that plans were developed over the years and will be developed in the future with clear Key Performance Areas and Indicators.

Performance must be assessed regularly so that remedial actions may be instituted in cases of underperformance and / or non-performance, but also to give appraisal where it is necessary.

ANALYSIS OF COMMUNITY NEEDS

HUMAN SETTLEMENT

These analyses emanate from community and stake-holder consultations that ensued during the process of crafting the Fifth Generation IDP 2022-2027

- There are RDP houses which remain incomplete and / or vandalized
- There is a need for the development of middle-income houses
- Residents who earn between low and high scales are not assisted to access the top-up subsidies to improve their houses or to as a startup.

PRIMARY HEALTH CARE

- Community wants the clinic to operate for 24 hours and to provide comprehensive primary care irrespective of what time patients arrive
- Clinics are very far from other sections of the municipality
- The clinics do not have necessary medication and medical needs most of the time.
- There is a need to engage the relevant department to raise these community concerns in this area.

EMERGENCY MEDICAL SERVICES

- Ambulance station is not central, and it create difficulties during call outs
- Fire and Disaster station is not central
- Fire and disaster is mostly unavailable, if available it is barely equipped

ROAD INFRASTRUCTURE

- Municipal roads are almost entirely dead
- Storm water system is very poor and does not cope during heavy rains

UNREHABILATED LAND

- The municipal area underwent extensive mining and was left un-rehabilitated
- Most of the areas are vulnerable to flash flood
- Borrowed pits / quarries must be rehabilitated

CEMETRIES / GRAVEYARDS

- The graveyards are almost all full
- The municipality does not have land to avail for the graves
- This matter has reached a crisis level
- There are competing needs for land, the municipality need land for human settlement also, should the land be available, this will provide a conundrum.
- Communities must be engaged to discuss alternatives; this discussion cannot be avoided lest it is too late.

COMMUNITY HALLS AND STADIA


- The municipality has committed a substantial capital resource on stadia and community halls.

GRACING LAND / PLOTS FOR FARMING


- There is a need to assess the municipal camps

- There is an urgent need of a policy to regulate the lease of municipal camps and its usage


